1. CHAIRMAN'S INTRODUCTION

Chairman's Introduction

Welcome to another annual report of the Yorkshire Dales Access Forum. It is hoped that you will find reading this account of our work both informative and interesting.

2005 saw the implementation of Open Access under the Countryside and Rights of Way Act 2000 in the Yorkshire Dales National Park. Much preparation work was undertaken by the National Park Authority with the Yorkshire Dales Access Forum advising and being consulted on a wide range of matters.

Early indications are that many of the problems and pressures envisaged by some have not materialised and that, in the main, users have been responsible and understanding of the needs of those that farm, own and manage the land over which the new rights can now be exercised. That said, the Forum will continue to ensure that the National Park Authority supports landowners who encounter problems with public access as well as informing walkers and users of their access rights.

In the past year, extensive work has been undertaken on both the Cumbria and North Yorkshire County Councils' Rights of Way Improvement Plans, with our Forum advising on the development of both plans through meetings and workshops. This work will continue in the coming year prior to their publication. These important plans will heavily influence future rights of way development within the Yorkshire Dales National Park.

The Yorkshire Dales Access Forum has welcomed new members during the year whilst other members have retired due to changing work commitments. Sadly, one of our members, John Sayer, died last December. He was an active and well respected member and his experienced farming and land owning perspective will be sadly missed.

The Forum remains a strong and increasingly powerful voice. The well balanced membership represents a wide range of views, with extensive experience of recreational, landowning and other relevant interests. I would like to thank the members for the considerable time, commitment and enthusiasm they have given the Forum over the last year. After three enjoyable years as Chairman I have decided to stand down as Chair, so enabling someone else to bring a new perspective and outlook to our meetings. I wish them well.

Lastly, I would once again like to thank the Officers of the Yorkshire Dales National Park Authority, who have serviced our meetings, kept us informed and ensured that our deliberations are productive.

2 THE YORKSHIRE DALES ACCESS FORUM

2.1 The Role of the Yorkshire Dales Access Forum

It is the function of Yorkshire Dales Access Forum, in respect to the Yorkshire Dales National Park, to **advise** -

- (a) Yorkshire Dales National Park Authority (as the appointing authority), and the local highway authority for any part of the area,
- (b) any bodies exercising functions under CRow Act Part 1 in relation to land in that area,
- (c) such other bodies as may be prescribed.

as to **the improvement of public access to land for the purposes of open air recreation and the enjoyment of the area, and as to such other matters as may be prescribed.** (CRow Act s94(4)).

In consequence of the above the Yorkshire Dales Access Forum may comment on any aspect of the management of local access undertaken.

For example:

- advise the National Park Authority on any long term restrictions or exclusions on access land in its area;
- advise the National Park Authority on how public access to land in its area should be managed so as to reduce the impact of access on agriculture, conservation or land management, or to reduce the risk to public safety;
- advise on the means by which information to the public on access land, including restrictions and opportunities should be provided;
- make representations to the Planning Inspectorate during the course of any appeal brought by a person with a legal interest in the land; and

Yorkshire Dales Access Forum may be requested to provide advice on:

- strategies or plans incorporating recreation and access which set rights of way and open access in a broad context, integrating provision for access, all forms of open air recreation to land and water, and transport, tourism, health and public information for example the Integrated Access Strategy for the Yorkshire Dales National Park, and the Cumbria Countryside Access Strategy;
- the extent to which fair provision is made for all current and potential users, and reflects the needs of local people and businesses; and the co-ordinated use of resources to provide and manage integrated recreation and access, and the dissemination of information to interested groups and the wider public.

Yorkshire Dales Access Forum is a statutory consultee on the Rights of Way Improvement Plans being produced by Cumbria and North Yorkshire County Councils.

3. WHO ARE THE FORUM?

3.1 Members and representation

The Forum has been constituted so that:

- It is a balanced group, which avoids being dominated by single interests.
- It is representative of all interests, including; recreation use, land management, nature conservation, tourism, business, transport and access for all.

Many members have secondary interests as well as the primary interest for which they were appointed.

4. WHAT'S HAPPENED IN THIS LAST YEAR (1 APRIL 2005 – 31 MARCH 2006)?

4.1 Chairman of the Forum.

Jon Beavan was Chairman of the Forum and Ben Heyes Vice-Chairman for the period of the report.

The Forum appointed Geoff Wilson as Chairman and Jon Beavan as Vice-Chairman at its meeting on 21 March 2006.

4.3 Informal Meetings of the Forum

The purpose of the meeting and site visit was to examine an application for an Open Access restriction direction of greater than six months to restrict or exclude access under part 1 of the CROW Act. The direction was for:

- Raven Ray Pasture, Ingleton
 - Quarry Wood, Ingleton
- 20 December 2005 at the Dales Countryside Museum, Hawes.

On the 20 December, a workshop was held to examine the Yorkshire Dales Assessment Area Maps for the North Yorkshire Rights of Way Improvement Plan. Comments were made and passed on to Officers of North Yorkshire County Council.

4.4 Main Activities of the Forum.

Several Members of the Forum have attended meetings as formal representatives of the Forum. These meetings have included work on the Cumbria Access Strategy, the Cumbria Rights of Way Improvement Plan, the North Yorkshire Rights of Way Improvement Plan, Yorkshire Dales National Park Authority green lanes working group and various regional Local Access Forum events.

The Forum responded to the consultations issued by DEFRA, Consultation Relating to the Amendment of the Local Access Forums (England) Regulations 2002. The response to this consultation can be obtained from the Yorkshire Dales National Park Authority.
