Licence

The Authority grants to the Licensee a non-exclusive Licence to use the RTM in connection with the Licensee's business, subject to the provisions of this Agreement.

Commencement and duration of licence

This Agreement shall come into force immediately and shall continue in effect until terminated in accordance with condition 5 of this Agreement or upon the RTM ceasing to be registered as a trade mark, or the Authority ceasing to be registered proprietor of the RTM, whichever shall first occur.

Conditions of this licence agreement

1. The parties shall jointly apply to the UK IPO to register this Agreement as a Licence.
2. The Licensee shall not use the RTM in any way that may bring the Authority or the RTM into disrepute or reduce, diminish or damage its reputation.
3. The Licensee may not assign this Licence or create any sub-Licence in whole or in part to any third party, and may not authorise any other person to use the RTM.

4. The Licensee shall co-operate fully with and use its best endeavours to assist the Authority in connection with any legal proceedings associated with this Licence and the RTM.
5. Either party may terminate this Licence by giving written notice to the other party, but the Authority will only terminate it within five years of the date on which this agreement has been signed on behalf of the Authority in the event of breach of any of these conditions by the Licensee. The Licensee, upon termination of the Licence by either party, must immediately cease all use of the RTM. The Licensee shall co-operate with the Authority in cancelling any registration of this Agreement as a Licence. Termination of this Licence by the Authority shall be without prejudice to any other right or remedy the Authority may have in respect of breach of this Agreement by the Licensee.
6. This Agreement constitutes the entire agreement between the parties, and supersedes any prior drafts, agreements, undertakings, representations, warranties and arrangements of any nature, whether in writing or oral, relating to previous permissions given to the Licensee by the Authority
7. Any application to vary this Agreement should be made in writing to the Authority. No variation of this Agreement shall be valid unless in writing and signed by both Parties to this Agreement.
8. A person who is not a party to this Agreement has no right under the Contracts (Rights of Third Parties) Act 1999 or otherwise to enforce or to enjoy the benefit of any term of this Agreement.
